Candesartan cilexetil, a nonpeptide, is chemically described as  $(\pm)$ -1-Hydroxyethyl 2-ethoxy-1-[p-(o-1H-tetrazol-5-ylphenyl)benzyl]-7-benzimidazolecarboxylate, cyclohexyl carbonate (ester).

Many research efforts are focused on finding ways to lower urinary protein excretion in patients with kidney disease because doing so may postpone kidney failure and prevent the development of cardiovascular disease. Investigators in Canada recently reported the results of a multicenter trial that evaluated whether high doses of the hypertension drug candesartan cilexetil could reduce proteinuria better than the maximum approved dose.

## USES :

Candesartan is used to treat high blood pressure (hypertension). Lowering high blood pressure helps prevent strokes, heart attacks, and kidney problems. This drug works by relaxing blood vessels so blood can flow more easily. Candesartan belongs to a class of drugs called angiotensin receptor blockers.

This medication is also used to treat congestive heart failure.

## **HOW TO USE :**

Take this medication by mouth, usually once or twice daily or as directed by your doctor. You may take this drug with or without food. Use this medication regularly in order to get the most benefit from it. To help you remember, use it at the same time(s) each day.


Do not take potassium supplements or salt substitutes containing potassium without talking to your doctor or pharmacist first. This medicine can raise your potassium levels, which can rarely cause serious side effects such as muscle weakness or very slow heartbeat. Tell your doctor immediately if any of these effects occur.

The dosage is based on your medical condition and response to therapy. For the treatment of high blood pressure, it may take 4 to 6 weeks before you get the full benefit of this drug.

# DOSAGE



No lethality was observed in acute toxicity studies in mice, rats, and dogs given single oral doses of up to 2000 mg/kg of candesartan cilexetil. In mice given single oral doses of the primary metabolite, candesartan, the minimum lethal dose was greater than 1000 mg/kg but less than 2000 mg/kg.

Treatment: To obtain up-to-date information about the treatment of overdose, consult your Regional Poison Control Center. Telephone numbers of certified poison control centers are listed in the Physicians' Desk Reference (PDR). In managing overdose, consider the possibilities of multiple-drug overdoses, drug-drug interactions, and altered pharmacokinetics in your patient.

# How Taken

Use Atacand as directed by your doctor. Check the label on the medicine for exact dosing instructions.

- \* Take Atacand by mouth with or without food.
- \* Continue to take Atacand even if you feel well. Do not miss any doses.

# **Missed Dose**

If you miss a dose of Atacand, take it as soon as possible. If it is almost time for your next dose, skip the missed dose and go back to your regular dosing schedule. Do not take 2 doses at once.

## Storage

Store at the room temperature away from moisture and sunlight. Keep out of the reach of children.

#### Note: Veterinary use

There have been anecdotal reports of oseltamivir reducing disease severity and hospitalization time in canine parvovirus infection. The drug may limit the ability of the virus to invade the crypt cells of the small intestine and decrease gastrointestinal bacteria colonization and toxin production.
