

SIDE EFFECTS

Terbinafine HCl, SIDE EFFECTS that may go away during treatment, include change in sense of taste, diarrhea, nausea, or itching.

If they continue or are bothersome, check with your doctor. CHECK WITH YOUR DOCTOR AS SOON AS POSSIBLE if you experience sore throat, fever, or vision changes.

The optimal clinical effect is seen some months after mycological cure and cessation of treatment. This is related to the period required for outgrowth of healthy nail.


Those with reduced liver or kidney function may need an adjustment to the dose. The length of treatment depends on the condition being treated and the severity of the infection.

Take Terbinafine 250 mg once daily, preferably at the same time each day.

Take this Terbinafine HCl by mouth, usually once a day, or as directed by your doctor.
